An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-421/2026

Shri Dope Ori -V/S- PIO-Cum-EE, PWD, Aalo, W/Siang District A.P.

ORDER

The 1st hearing held on 17th Sept '2026, related to the **APIC No-421/A/2026**. The Appellant Dope Ori, present during the hearing.

The PIO represented by APIO Kenpak Ngomdir Assistant Engineer AE (PWD), Aalo Division Govt. of Arunachal Pradesh is present.

Heard the Appellant

The Appellant stated that even after order from the First Appellate Authority (FAA) on dated 3/7/2026, ordering the PIO to furnish the information to him before 13/08/2026, the PIO has not provided any information to him till today.

Heard the APIO.

The APIO stated that office of the PIO has not received the form 'A' of the Appellant till now and therefore, the office of the PIO has written a letter to the Appellant on **18/07/2026** that the office of the PIO has not received such application/form 'A' from the Appellant to which the Appellant has not replied back to the PIO till now and therefore, the information has not been furnished to him till now.

After hearing both the parties the Commission hereby observes that the PIO has not received the form 'A' of the Appellant and therefore, taking into consideration the statements of the APIO the court of the Commission hereby provides a soft copy of the Appellant's form 'A' to the APIO and pass the below order;

- The PIO to be provided all the information as applied by the Appellant on or before the next date of hearing and the PIO to be present in the next hearing without fail, **failing which the Commission will imitate action against the PIO as per the previsions of the RTI Act 20-05.**
- The Appellant to be present in the next date of hearing without fail, **failing which the Commission will presume that PIO has furnished all the information to him and thereby this appeal will be heard and determined ex-parte by way of disposing it.**
- Notice for next the date of hearing need not be sent to both the parties as both the parties are present today.

The Commission hereby orders;

The next date of hearing be fixed on **26th Nov'2026 at 10:30 AM (Morning)**
