Shri Chungma Sangbia -V/S- PIO-Cum-Director, SJETA, Itanagar, P/Pare District A.P.

ORDER

The 2nd hearing held on **8th September' 2026'** related to the **APIC-No-189/A/2026**.
The Appellant Shri Chungma Sangbia is present during the hearing before the Commission.

The PIO-cum-Director, SJETA Department, Itanagar, Papumpare District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has not provided any information to him till now, except a letter dated 10.11.2025 stating that the information fall under the exemption provisions under Section 8(1)(e) and 8(1)(j) of RTI, Act, 2005, and that it falls under fiduciary relationship and personal information respectively.

Heard the PIO;

The PIO stated that as the information are not available with his office but available with the respective district officers, he has written to the officers in the district of Kurung Kumey, Papumpare, West Siang and Changlang to provide the information to him so that he can further furnish the same information to the Appellant, and consequently the information from Changlang district has been received and the information(s) are ready at his office to be provided to the Appellant, and thereby, the Appellant can come on any working day to collect the information pertaining to Changlang District.

For the information pertaining to Papumpare District, Kurung Kumey District and West Siang District, letter for providing the information as sought by the Appellant will be sent tomorrow itself again, so that the information sought under Form-A be further furnished to the Appellant. Therefore, the PIO seeks some more time, so that the office of the PIO can provide the information to the Appellant.

After hearing both the parties the Commission hereby order as follows;

- i) The PIO to obtain the relevant and required information from Papumpare District, Kurung Kumey District and West Siang District to furnish the information to the Appellant on or before the next hearing.

- ii) The Appellant to collect the information pertaining to Changlang District from the office of the PIO on any working day from today.
- iii) The Appellant to be present in the next hearing without fail, failing which this appeal will be heard and determined ex-parte.
- iv) The PIO to provide the information collecting it from the concerned districts, so that, the information can be furnished to the Appellant before the next hearing.
- v) The PIO to be present in the next hearing without fail, failing which the Commission will initiate necessary action as per the provisions of the RTI, Act, 2005.
- vi) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing before the Commission, today.

The Commission hereby orders;

The next date of hearing be fixed on 12th day of November' 2026 at 10:30 AM (Morning).
