Shri Katung Tana -V/S- PIO-Cum-Executive Engineer, PWD, Lemmi, Pakke-Kessang

ORDER

The 3rd hearing held on **8th September' 2026'** related to the **APIC-No-793/A/2025**.
The Appellant Shri Katung Tana is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), PWD, Pakke Kessang Division, Govt. of Arunachal Pradesh is represented by Shri Tamchi Kanu, Junior Engineer, PWD, Pakke Kessang Division, with a letter of authority dated 08.09.2026 from the PIO during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has deposited the fees for the information amounting to Rs. 1,126/- (rupees one thousand one hundred twenty six) to the office of the PIO through treasury challan, but still the information(s) have not been provided by the PIO.

Heard the representative of the PIO;

The representative of the PIO stated that the PIO with the information copies had started from Seppa this morning, but unfortunately the road has been blocked at the Pakke Kessang-Sagalee Road by the Sagalee Students' Union in connection with their various charter of demands, if the road block had not been there, the information copies could have been provided to the Appellant today in the court of the Commission.

After hearing both the parties, the Commission hereby order as follows;

- i) The Appellant to collect the information personally from the office of the PIO.
- ii) The PIO to provide the information to the Appellant as and when he comes to collect the information on any working day.
- iii) The Appellant to be present in the next hearing to let the Commission know whether the information provided by the PIO are complete or not.
- iv) The PIO to be present in the next hearing without fail, failing which necessary action as provided under the RTI, Act, 2005 shall be initiated against the PIO.
- v) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 12th day of November' 2026 at 10:30 AM (Morning).
