ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Lajamang Mannow, Village Nanam Khamti, P.O. Manmow, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 07/03/2025 regarding Improvement of Bomjir – Paglam road (Bizari to Anpum, L-13.400 km).
- 2). **The 4th hearing was held on 31st March' 2026 (Tuesday).** Shri Keni Zirido, PIO-Cum-EE(PWD), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh and the Appellant Chow Lajamang Mannow appeared before the Commission through online video conferencing.
- 3). The Appellant informed that the PIO had not furnished remaining information as directed by the Commission.
- 4). The PIO submitted the remaining information, Sl. No. n & p. of the Form- A dated 07/03/2025 had been sent to the Appellant through registered post on 27th February'2026. The PIO showed the postal service receipt to the Commission. The PIO also submitted that due to VIP visit he could not attend the last hearing personally, therefore, had sent authorized representative on his behalf.
- 5). The Commission cautioned the PIO to give preference to statutory duty over other VIP visits. The Commission asked the Appellant to confirm receipt of mail from the Post Office and intimate to the Commission within seven days from the date of issue of this order.

6). Next course of action shall be taken on intimation from the Appellant. However, if the Appellant failed to intimate to the Commission within ten days from the above time given the case shall be disposed of.

Order be issued to all the parties.
