**Information sought:**

The appellant filed an RTI application dated 17.08.2024 seeking following information regarding PMKSY-WOC 2.0-11/2021-2022 at Langro, Koduk valley and Nibi under Nyobia circle.

Furnish the following documents within 30 days

1. Furnish the Technical sanction order copy.
2. Furnish Name & Address of contractors/firm/name of Firm owner/Proprietor.
3. Furnish the NIT copy (if possible).

4. Furnish the details bid documents of contractor (Technical & Financial)
5. Furnish Name of work with Geo-tag report of each project.
6. Details of Payment with money receipt of contractors i.e. cheque book, counterfoil/deposit challan.
7. Give account statement of department.
8. Give DPR copy.
9. Give MB Book.
10. Give First and Final Bill.
11. Give Photocopy of work site from starting to end/Certified photocopy of work site by concern officer.
12. Furnish all the documents in Certified True copy.

**Relevant facts emerged during hearing:**

Previous Hearing:

First hearing : 13.03.2025

In first hearing ordered as: "*The commission has directed the FAA – Deputy Commissioner, Kurung Kumey, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within three weeks from the date of receipt of this order i.e. on or before **03.04.2025**.*"

The following were present.

**Appellant** : Absent.

**Respondent PIO** : Absent. Represented by Shri Bamang Taba EO (RE). He states that information is kept ready to furnish.

**Decision:**

The Commission after advertizing to the facts and circumstances of the case, hearing the party and perusal of the records, observes that FAA has not yet disposed off the first appeal filed to him though he has passed an order dated 2.5.2025. The appellant has filed 2<sup>nd</sup> appeal to this commission again on 1.7.2025 before the first appeal is finally disposed off by the FAA.

**Now Therefore**, the instant appeal case is again remanded to First Appellate Authority. Therefore, the **FAA- Deputy Commissioner, Kurung Kumey District**, Koloriang shall ensure implementation of the order passed by him on 2.5.2025 and finally dispose off the appeal filed to him within two weeks from the date of issue of this order.

1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
