ORDER

The 1st hearing held on 24th **March'2026** related to the **APIC No-862/2025**. The Appellants Shri Donik Roru present during the hearing and PIO-cum EE (PWD) Palin Division is also present during the hearing through online mode.

Heard the Appellant;

The Appellant stated before the Commission that PIO has not provided any of the information till now.

Heard the PIO;

The PIO -cum EE ((PWD), Palin Division, has requested the Commission to give some more time so that he will furnish the information to the Appellant as applied by in his form "A". The PIO has written a letter to the AE Gangte Sub- Division to provide the information so that he can provide the same information to the Appellant but due to transfer of the incumbent A.E the information have not been furnished to the PIO and so, till now the information have not been furnished to the Appellant but I assure the court of the Arunachal Pradesh Information Commission (APIC) to provide the information within 1(one) month from today.

Taking into consideration the statements of the PIO the Commission hereby orders;

- i) The PIO to provide the complete information to the Appellant within 1(one) month from today and, to be present in the next date of hearing to apprise, this court of the information being furnished to the Appellant or not.
- ii) The Appellant to appear in person or through online mode before the Commission, in the next date of hearing without fail, **failing which his appeal shall be heard and determined ex-parte.**
- iii) The next date of hearing has been intimated to the both the parties. Notice need not be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 9th June 2026 at 2:30 PM (Evening).
