An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 198/2026.

APPELLANT : Shri Bengia Papo, Akum Hapa Colony chimpu.
RESPONDENT : The PIO, o/o the Dy. Commissioner, Bichom District, Nafra.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bengia Papo for non-furnishing of below mentioned information by the PIO, o/o the Dy. Commissioner, Bichom District, Nafraas sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 23.09.2025.

A. Particular of information: To furnish all the relevant information against implement of fund for livelihood Generation Activities of Puroik community for Trade/ Business of entire Bichom District Arunachal Pradesh as per the detail list/ name of beneficiaries is enclosed herewith 2019-2020 & 2021-2022

B. Details of information required:

1. Furnish the full name and address of beneficiaries with their mobile number/Xerox copy of Aadhar card /Pan card/ST/PRC/Voter ID/cash memo/money receipt of tempo/ Auto with RC book along with the dealer contact number.
 2. Furnish the beneficiaries payment money receipt list with their full name and address/ mobile number/ Xerox copy of Aadhar card/Pan card/ST/PRC/Voter ID/cash memo/money receipt of tempo with RC book/ vegetable shop/Meat shop/Tent house/ Auto/ Mobile shop/ Wholesale grocery/ Poultry/Computer photocopier/ Tailoring and weaving cloth/ Gumti shop/ Tea stall/Handicraft shop/ Fair price shop/ Animal husbandry/ Piggery/Goatary/ Mobile kiosk/Carpenter/Garment shop/Stationery shop/ Computer shop.
 3. Furnish the coloring photocopy of all the works site/ items with its locations.
 4. Furnish the Xerox copy of cheque leaf/ PFMS/DBT/Pay in slip for NEFT/RTGS details against all the beneficiaries.
 5. Furnish the bank account number of all the beneficiaries with Xerox copy of Aadhar card/PRC/Pan card/ST.
 6. Furnish the name of officers & officials with their designation.
 7. Furnish the Xerox copy of GST return filed for work wise or year wise with showing deduction of % against above mentioned fund.
 8. Furnish the money deposited challan of Govt, account against GST/royalty by DC Kurung Kumey District in work /selecting the beneficiaries list.
 9. Furnish the undertaking copy of the selected beneficiaries along with the contact number & Deed of acceptance letter along with officials name/address.
 10. Furnish the name of officers & officials with their signature/seal/stamp who have executed the work.
 11. Furnish the amount of money deposited in personal account of Puroik beneficiary list as per Rs 2,00,000/- (Rupees Two Lakhs) only from the beneficiary selected list along with their mobile number, fathers name, address, along with 3 Nos. of pass photo size and with their bank account number in which the money has been deposited.
- C. Period for which information asked for: 2020-2025.**

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the appellant, Shri Bengia Papo had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to approach the Deputy Commissioner, Bichom District, Nafra, Arunachal Pradesh the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide his Memo of Appeal dtd. 17.11.2025. There is, however, no record of the FAA's conducting the hearing and the order, if any, thereon.

The appellant, apparently, disappointed, filed his 2nd appeal before this Commission under section 19 (3) of the RTI Act. 2005 vide his Memo of appeal dt. 11.02.2026 which is, accordingly, listed for hearing in this Commission today on 12.06.2026 wherein the PIO, Shri L.W. Bapu, Addl Deputy Commissioner (ADC)-cum-PIO, o/o the Deputy Commissioner, Bichom District, Camp Nafra is present through VC but the appellant, Shri Bengia Papo is absent without any intimation.

Hearing & decision:

Heard the PIO who submitted that the requested information / documents have been furnished to the appellant vide letter dt. 28.05.2026 (as reproduced hereunder), a copy whereof has been forwarded to this Commission during the course of hearing through Whatsapp.

Here, it may be noted that Bichom District was created on 23rd February 2024 vide The Arunachal Gazette Notification No. Law/Legn-5/2024. Therefore, the information sought in the RTI application for the period 2020-2025 is not applicable/available in respect of Bichom District for the period prior to its creation.

Moreover, the information sought for the mentioned period may be obtained from the office of the Deputy Commissioner, West Kameng District and the office of the Deputy Commissioner, East Kameng District, under whose jurisdiction the areas presently falling under Bichom District were earlier administered.

If you are not satisfied with the reply, you may prefer an appeal before the First Appellate Authority within 30 days from the date of receipt of this letter under Section 19(1) of the RTI Act, 2005.
