ORDER

The 2nd hearing held on 9th June' 2026 related to the APIC- No-862/A/2025. The Appellant Shri Bamang Pacho is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), PWD, Palin Division, Kra-Daadi District, Govt. of Arunachal Pradesh, found absent during the hearing, despite notice for hearing today, sent to him on 24th March' 2026, the PIO is absent, without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

The Appellant stated that the PIO has not provided him any information till today.

After hearing the Appellant and taking the absence of the PIO seriously the Commission hereby orders;

- i) To issue bailable warrant of arrest against the PIO-cum-Executive Engineer, Palin Division, Kra-Daadi District, for securing his attendance in the Third Hearing of this appeal, which is fixed on 27th day of August' 2026 at 10:30 AM.
- ii) To issue order to the Officer-In-Charge, Palin Police Station, Kra-Daadi District, for executing the bailable warrant of arrest and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **27.08.2026, at 10:30 AM, without fail**, before this court.
- iii) The copy of this bailable warrant of arrest be served to the Superintendent of Police, Kra-Daadi District for compliance.
- iv) The copy of this bailable warrant of arrest be served to the Deputy Commissioner, Kra-Daadi District for information.
- v) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 27th day of August' 2026 at 10:30 AM (Morning).
