Relevant facts emerging from appeal:

Information sought:

The appellant filed an RTI application dated 10.09.2024 seeking following information regarding C/o "Integrated Infrastructure Development for Tourism at Tawang with the provision of sewage and water treatment plant at Tawang District, under the North East Special Infrastructure Development Scheme (NESIDS) in Arunachal Pradesh during the financial year 2020-21.

Particulars of sought information:

1. Furnish the Certified Sanction Order Copy of the total list of project mention above.
2. Furnish the total lists of Work Components of the Projects.
3. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mention above.
4. Furnish the Certified copy of Newspaper in which the NIT was Published (at least 3 Newspaper name (one national & 2 local) along with the date of publication of newspaper as per Govt. approved order.

5. Furnish the Tender Evaluation copy (Technical Bid) along with the list of Firms participated in the tender processed for the work.
6. Furnish the Name of Firm who won the tender work with respect to the subject mentioned above.
7. Furnish the certified copy on which Date the project has been started.
8. Furnish the Geo Coordinate information for the work mentioned above.
9. Furnish the certified full agreement copy made in between the executing agency and the firm owner.
10. Furnish the certified copy of Contractor Registration of the winning firm.
11. Furnish the certified copy of Contractor Enlistment update reports, of tender winning firm.
12. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018).
13. Furnish the certified copy of declaration letter from the contractor (if the tender participant is from different state) to the effect that he/she has not been debarred from tendering by authority in which contractor is registered (As per CPWD Work Manual 2014, Section 15.2.3(2)).

Relevant facts emerged during hearing:

Previous Hearing:

First Hearing : 03.04.2025

In first hearing ordered as: "*The Commission has directed the appellant to examine the information received from the PIO. In case he is not satisfied with the information received, he shall file a written submission within 10 days from the date of issue of this order to the PIO specifying the shortfall, if any, under intimation to this commission. The PIO shall dispose of such written representation when received within two weeks from the date of receipt under intimation to this commission*".

The following were present.

Appellant : Present.
 He states that in compliance of this commission's order dated 3.4.2025 he has submitted a written statement dated 7.4.2025 to PIO stating that information sought at serial no. 1, 4, 11, 12 and 13 of RTI application is not furnished to him.

Respondent PIO : Absent.
 Shri Jobom Bam, JE represented the PIO.
 The representative of the PIO states that the letter dated 7.4.2025 of appellant has not been replied to. However, he has contested that the information at serial no. 1, 4 & 11 was already furnished in the first information document furnished to the appellant. Information pertaining to serial no. 12 and 13 are not available.

Decision:

The Commission after advertizing to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the PIO has not disposed of the written submission dated 7.4.2025 made to him by the appellant. The information said to be furnished for serial no. 1 of RTI application is only the covering / forwarding letter of the sanction order. The information furnished by the PIO against serial no. 4 and 11 are adequate and information pertaining to serial no. 12 and 13 are said to be not available.

Therefore, the PIO is directed to dispose of the representation dated 7.4.2025 submitted to him by the appellant within two weeks from the date of issue of this order i.e. on or before 5th August' 2025 under intimation to this commission with following contents:

Against serial no. 1 : Furnish a copy of the Sanction Order of the Project.
Against serial no. 4 and 11: Information already furnished.
Against serial no. 12 and 13: Information not available.

The appellant shall obtain the above information from the PIO within stipulated time and submit a report to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report from PIO and appellant is received at commission within the stipulated time, this appeal case shall stand closed.
