ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Silamang Choumoung, Village Piyong Khampti, P/O- Piyong, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-CDPO, The Child Development Project Officer, Lekang (Mahadevpur) Circle, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/07/2025 regarding execution of Supplementary Nutrition Programme in Lekang Circle under Namsai, Arunachal Pradesh.

2). The re-scheduled 1st hearing was held on 17th March' 2026. Ms Miti Siboh, PIO-cum-CDPO, Child Development Project Officer, Lekang (Mahadevpur) Circle, Namsai District, Arunachal Pradesh, appeared before the Commission's court through online video conferencing. The Appellant Chow Silamang Choumoung was present in person.

3). The PIO submitted that the Appellant was informed to collect information but he had not turned up. The FAA had also summoned for the hearing but the Appellant was found absent, so the case was disposed of.

4). The Appellant informed that he had received the summon notice from the FAA on the day of the hearing in the evening after it was over. So, he could not attend the hearing of FAA.

5). The Commission advised the Appellant to seek specific and limited information so that the PIO could furnish information within the prescribed period. Also, seek only the requisite information through which mismanagement of project, if any, can be proved.

6). The Commission directed the PIO to furnish all the available information to the Appellant within fifteen days from the date of issue of this order. The Commission also directed the Appellant to collect information from the office of the PIO within fifteen days from the date of issue of this order and intimate his satisfaction or dissatisfaction to the Commission within twenty days from the date of issue of this order, failing which the case shall be disposed of.
