ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, Sood Village, Naharlagun, PO/PS Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(RWD), Seppa Division, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 06/11/2025 regarding **LO27-500 mtrs Seppa-C/Tajo road to Tasamlora state-I & II.**

2). **The 1st hearing was held on 9th June' 2026.** Shri M. Riba, PIO -cum- EE(RWD), Seppa Division, East Kameng District, Arunachal Pradesh was absent. The Appellant Shri Mamo Sono, was present in person.

3). The Appellant informed the Commission that he had contacted Dealing Assistant of the PIO, the DA had asked him to give some more time to provide information.

5). **The next date of hearing is fixed on 11th August'2026 (Tuesday) at 11am.**

6). **Therefore**, the Shri M. Riba, PIO -cum- EE(RWD), Seppa Division, East Kameng District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
