**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengai Mama, Dariya Hill Colony, near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding construction of Suspension Bridge over Kojen river in between Rigia to Duchok in Upper Subansiri District, Arunachal Pradesh.
- 2). The 1<sup>st</sup> re-scheduled hearing was held on 17<sup>th</sup> March' 2026 (Tuesday) at 1100 hrs. Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh was absent. The Appellant Ms Bengia Mama was present.
- 3). The Appellant informed that the PIO had called here telephonically in the month of September'2025 and had assured to furnish information but till date no information had been furnished.
- 4). The Commission viewed the absence of the PIO, without any justifiable reason, seriously.
- 5). The Commission hereby directs Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh to **SHOW CAUSE as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005.** The reply should be submitted to the Commission before the next date of hearing.
- 5). The next date of hearing is fixed on 28<sup>th</sup> April'2026 (Tuesday) at 1100hrs.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action under section 20(1) of the RTI Act, 2005, and issue Arrest Warrant under section 18 (3)(a) of the RTI Act, 2005 to compel attendance and recommend disciplinary action under Section 20 (2) of the RTI Act, 2005 . In case Appellant is found absent the case shall be disposed of without any further notice.
