**ORDER**

The 4<sup>th</sup> hearing held on 19<sup>th</sup> March' 2026' related to the APIC No-108/2025. The Appellant Mamu Sono is present during the hearing before the Commission.

The PIO-cum-Deputy State Project Director (DySPD), ISSE, Itanagar, Papumpare District, Govt. of Arunachal Pradesh is present during the hearing before the Commission..

**Heard the Appellant;**

The Appellant stated that he has received all the information(s) particularly dealt by the office of the PIO-cum-DSPD, ISSE Itanagar, Govt. of Arunachal Pradesh.

**Heard the PIO;**

The PIO stated that the information(s) which are available with his office have been provided to the Appellant, and other information(s) which are executed by another executing agency, he has written a letter to the competent authority i.e Executive Engineer, Engineering wing, department of education to provide the information(s) to the Appellant.

Despite his letter to the Executive Engineer, Engineering wing, department of education, non furnishing of the information to the Appellant he has again sent a reminder letter to furnish the information to the Appellant, by which, the competent authority has compiled the information and brought to the court to be furnished to the Appellant in hard copy.

After hearing both the parties and their statement and the submission of the remaining information(s) which are not with the instant PIO the Commission hereby orders;

- 1) The PIO-cum-EE, Engineering wing, department of education to handover the information(s) which have been provided by the Engineering wing, department of education, ISSE, to the Appellant before the court today.
- 2) On the complete information provided to the Appellant by the PIO-cum-DSPD, ISSE, Govt. of Arunachal Pradesh, the Commission hereby severe out the PIO from this instant appeal by disposing of the appeal filed against him by the Appellant, and therefore, the instant PIO-cum-DSPD is severed out of this appeal as appeal against him stands disposed of and closed.

- 3) The information provided by the Executive Engineer, Shri Gyamer Natung, Engineering wing of the education department, Govt. of Arunachal Pradesh is included as a party to this appeal and made the Respondent PIO herein.
- 4) The Appellant to go through the information(s) provided to him by the PIO-cum-EE, Engineering wing, department of education and let the Commission know whether the information(s) furnished are complete or not as per his application in the next date of hearing.
- 5) The PIO-cum-EE, Engineering wing, department of education to be present in the next date of hearing without fail, failing which necessary action as provided under the RTI, Act, 2005 will be initiated against him.
- 6) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- 7) Notice for next date of hearing in particular to the PIO-cum-EE, Engineering wing, department of education Govt. of Arunachal Pradesh is informed through Shri Margo Basar, Office Assistant, ISSE as dasti-service.
- 8) Notice for the next date of hearing need not be sent to the Appellant as he is present during the hearing.
