An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC- 19/2026.

APPELLANT : Shri NabamTadap, Langdung Village, Sandupota Circle.
RESPONDENT : The PIO, o/o the EE (PWD), Doimukh Division, Papum
Pare District.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tadap for non-furnishing of 14(fourteen) point information regarding c/o Approach road from Airport to Hollongi Mikir Village by the PIO, o/o the EE (PWD), Doimukh Division, Papum Pare district as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 15.09.2025.

This appeal was heard 2(two) times on 10.06.2026 and 19.08.26.

On 19.08.26, the following order was passed:

"Today on 19.08.2026, the appellant is present in person but the PIO, through his Junior engineer, informed vide letter dt. 19.08.2026 that due to his pre-occupation on account of visit of DONER Ministry officials, he will not be able to attend the hearing and requested for adjournment of the hearing.

This hearing of this appeal is, therefore, adjourned to 16th September, 2026. The PIO is directed again, in the interim, to furnish the information and report the compliance thereof to this Commission on that date failing which this Commission shall be constrained to initiate penal action under section 20 of the RTI Act, 2005."

Today on 16.09.26, the appellant is present in person while the PIO is represented by Er. Shri Yarkap Welly, AE-cum-APIO who has produced the copy of PIO's letter dt.15.09.2026 by which the requested information were furnished to the appellant as under:

This Commission, upon perusal of the information / documents furnished by the PIO, as above, observes that the PIO has furnished all the requested documents except with respect to the queries at. Sl. 2, 5 and 14.

It is the requirement of law under section -7(8)(i) read with section-18(3)(c) of the RTI Act, 2005 and rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005 that when a particular information/documents denied the reasons/clarification thereon has be furnished on an affidavit as has been demanded by the appellant during the hearing.

The PIO is, therefore, directed to furnish appropriate replies/explanation to those three queries on an affidavit within 7 days from the date of receipt of this order and thereafter, within one week, the appellant shall intimate this office of the receipt of the document for further consideration.

During the course of hearing the appellant also complained that the PIO despite this Commission's order dt.19.08.2026 passed in APIC-20/2026 to furnish the documents / information pertaining against query No. 19, did no furnish the same and pleaded that the PIO be directed to furnish the reply to that query also on an affidavit. This Commission, endorses the prayer of the appellant and accordingly, directs the PIO to furnish an appropriate reply/explanation to that query on an affidavit as well (separately) within 1(one) week from the date of receipt of this order so as not to compel this Commission to invoke section 20 of the RTI Act, 2005.
