ORDER

The 1st hearing held on 4th June '2026 related to the APIC No-188/2025. Both the parties are present during the hearing through online mode.

Heard the Appellant;

The Appellant stated before the Commission that the PIO has not provided any of the information(s) till today.

Heard the PIO;

The PIO stated that she has written a letter to the Appellant on 24/10/2025, to clearly /specify as to out of the 17 (seventeen) schemes under Campa for the year 2024-2025, which scheme information the Appellant is seeking in his Form'A', and regarding sl no 3 and 4 of the Form'A the information sought are personal information /personal data and therefore the same cannot be given to any individual without permission and consent of the 3rd parties due to which a letter will be written to all those people asking their permission if their personal documents can be given to the Appellant or not, regarding sl no 5 these are private and personal data and this information cannot be given to private individual, regarding 6,9 & 10 the information will be provided to the Appellant on or before the next date of hearing and regarding sl no. 7& 8, information cumulatively corresponds to 98 work executed s in 6(six) range which infact is vague and to compile the same it will be needing a staff to be engaged for a whole month, and therefore, the Appellant is requested to clarify as to which of the works out of the 98 works information is sought, for the information to be furnished with ease by the office of the PIO

After hearing both the parties the Commission hereby order;

- i) The PIO to provide the information as applied by the Appellant in his form 'A' and marked as sl .no -6,9 & 10 and regarding the information as sought in sl .no 3,4 & 5 the consent and permission of the 3rd party to be sought on or before the next date of hearing for which a copy of the same letter to be provided to the Appellant.

- ii) Regarding sl. no-7 & 8, the Appellant to clarify/ specify to the PIOs to which works information out of 98 works he need.
- iii) The information pertinent to sl No-1,7 and 8 be specific/clarified to the PIO by the Appellant on or before the next date of hearing by which the information can be provided to the Appellant by the PIO.
- iv) The next date of hearing has been intimated to both the parties.
- v) Notice need not be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 20th August 2026 at 10:30 AM
