ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa, Po/Ps-Seppa, East kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/07/2025 regarding Category of Work Charged (W/C) serving under Bomdila Division.
- 2). The 2nd hearing was held on 17th March' 2026. Er. Thanu Rangradu, PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh and the Appellant Shri Ashok Sangbia appeared before the Commission's court through online Video Conferencing.
- 3). The Appellant informed that information had been furnished but Recruitment Rules (RR) and appointment order of the W/C staff had not been furnished by the PIO. Further, he also stated that the department is appointing staff without Recruitment Rules.
- 4). The PIO submitted that Recruitments are done under the Superintendent Engineer and the Recruitment Rules are framed by the Administrative Reform Department and therefore, the appointment orders would be available in the office of the Superintendent Engineer and the RR in the website of the Administrative Reform Department.

- 5). The PIO also submitted his response to the Show Cause notice intimating that he had undergone major surgery so was unable to attend the previous hearings.
- 6). The Commission asked the Appellant to approach the concerned Superintendent Engineer for the appointment orders of the W/C staff and directed him to visit the website of the AR Department for the Recruitment Rule. In case, if not available on the website, the Appellant should approach the AR Department for the RR.
- 7). The Commission also hereby directs the Superintendent Engineer (PWD), Bomdila , West Kameng District Arunachal Pradesh and the Administrative Reform Department, A.P. Civil Secretariat, Itanagar to furnish information to the Appellant as and when he approaches. This Appeal case of the Appellant is hereby closed.
- 8). The Appeal case shall be disposed of on submission of valid Medical Reports / Medical Certificate by the PIO to prove his statement for the absence from the court hearing. Till then the Appeal case is kept in abeyance.
