Information sought:

The appellant filed an RTI application dated 06.11.2024 seeking following information regarding Project/work sanctioned under Article 275 (1) of the constitution of India, by the Ministry of Tribal Affairs Govt. of India during the financial year **2017-21** during the financial year **2024-25**.

The total list of work/projects are as follows:

1. Integrated Fish Farming (Pig- cum Fish culture) at Yingkoing&Jengging Circle, Upper Siang Dist. Arunachal Pradesh. (2020-21)
2. Establishment of Orange Garden at Pane Kenyung area in Karko village under CD block Jengging, Loleng-Lobo area in Pugging village and Hieng-Pinying-Kiyit area of Simong under CD Block Yingkiong, Upper Siang Dist. (2020-21)
3. C/o Foot Suspension Bridge over Yananchu river (border area) in between Mankota village &Dewakota in Upper Siang Dist. (2017-18)

Particulars of sought information are given below: -

C/o "The total list of work/projects:

1. Furnish the certified Sanction Order Copy.
2. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status with the districts as per Rule 4(ii)(b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
3. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
4. Furnish the certified LOC Copy with respect to the subject mentioned above.
5. Furnish the certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
6. Furnish the certified copy of Utilization Certificate.
7. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
8. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
9. Furnish the certified copy of Completion certificate of the project.
10. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, as per Government approved Order.
11. Furnish the certified Design and Scope of Work in the projects.
12. Furnish the certified copy of Work Specification of the projects.
13. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
14. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
15. Furnish the Name of Officers and their Designation at the Time of monitoring the work.
16. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
17. Furnish the certified copy of Contractor Enlistment Update reports (Civil/ Composite Category as per the nature of work), of tender participant and winning Firm.
18. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
19. Furnish the certified Integrity Pact submitted by the tender participant.

20. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018 as per District Based Entrepreneurship Act, 2015 & 2020).
21. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
22. Furnish the certified copy of Acceptance letter for Tender work by the Executing Agency to the tender Winning Firm.
23. Furnish the certified copy of Work Order given to the Contractor by the Executing Department.
24. Furnish the Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.
25. Furnish the certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy Paper) after completion of work.
26. Furnish the Geo Coordinate information for the work mentioned above.
27. Furnish the certified Payment Details (Cheque no., voucher, PFMS etc. (Which ever method is used of payments)) of the project till date.
28. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
29. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
30. Furnish the certified Affidavit to invest cash up to (25% of tender value) submitted by the tender participant.

The following were present.

Appellant : Present. He states that he has received some information but the information documents furnished to him do not exactly conform to the information sought in RTI application and wish to return the information documents to the PIO. He further states that the First Appellate Authority has not heard the first appeal filed to him

Respondent PIO : Present through VC. He states that the FAA – DC, Yingkiong office has directed him to furnish the information to the appellant, accordingly the information documents were sent to the appellant through speed post. He has produced documentary evidence of letter from DC Yingkiong office and the copy of forwarding letter to the appellant despatching the information documents.

FAA : Absent.

Decision:

The Commission after advertizing to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that FAA has directed PIO to furnish the information sought to the appellant. The appellant has stated that he has received the information but it is not serially conformed to the information sought in RTI application. The appellant is directed to specify the shortcoming in the information furnished to him and file a written submission to PIO and obtain acknowledgement within ten days from the date of issue of this order under intimation to this commission. The PIO shall furnish the additional specified information within the purview of original RTI application in form – A within one week upon receipt of written submission from the appellant under intimation to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant, this appeal case shall stand closed.

Order pronounced in the Open Court of this Commission today this 24th day of July' 2025. Each copy of the Judgement / Order be furnished to the parties.


