Shri Bengia Tahar -V/S- PIO-Cum-EE, PWD, Koloriang, K/Kumey District A.P.

**ORDER**

The 2<sup>nd</sup> hearing held on **31<sup>st</sup> March' 2026'** related to the **APIC No-632/A/2025**. The Appellant Shri Bengia Tahar is present during the hearing before the Commission.

The PIO-cum-EE, PWD, Sangram Division, Kurung Kumey District, Shri Modak Riba is represented by Shri Bini Tare, PA to EE-cum-Incharge RTI cell.

**Heard the Appellant;**

The Appellant stated that PIO has not provided him any information till now.

**Heard the representative of the PIO;**

The representative of the PIO stated that the present appeal for which the hearing is held today, the work comes under the Koloriang PWD Division, and therefore, all the information(s) related with this Form-A application of the Appellants are with the PIO-cum-EE, PWD, Koloriang Division, for which the PIO-cum-EE, Sangram Division has written to the Executive Engineer Koloriang Division by handing over all the files and information(s) related with Koloriang Division jurisdiction, after it was bifurcated to two divisions, from Sangram division.

And therefore, the present PIO be severed from this appeal as a party and join the Executive Engineer PWD, Koloriang Division as the PIO as well as the respondent to this appeal.

After hearing both the parties the Commission hereby orders;

- i) As Sangram PWD Division was bifurcated into two (2) divisions namely Koloriang Division and Sangram Division the work executed under the jurisdiction of Sangram Division and Koloriang division have been divided amongst the two old and new division. In the present context the fact is that the impleaded respondent who is the PIO-cum-EE, PWD, Sangram Division does not have the information for the appeal heard today. And therefore, the present respondent/PIO be severed out from being the respondent and enjoin Shri Yomken Karga, the PIO-cum-EE, PWD, Koloriang Division as the PIO herein for hearing this appeal further.

- ii) Send Summons to the PIO-cum-EE, PWD, Koloriang Division, Kurung Kumey Distirct, Govt. of Arunachal Pradesh to be present in the next date of hearing to answer the appeal without fail, failing which necessary action as provided under the RTI, Act, 2005 will be initiated against the PIO.
- iii) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be beard and determined ex-parte.
- iv) Shri Bini Tare shall inform the PIO-cum-EE, PWD, Koloriang Division of the next date of hearing.
- v) Notice need not be sent to both the parties because both the parties are present today.

**The Commission hereby orders;**

**The next date of hearing be fixed on 18<sup>th</sup> day of June' 2026 at 10:30 AM (Morning).**
