An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-364/2026.

APPELLANT : Shri Bagemso Mitti, New Hatiduba, Sunpura.
RESPONDENT : The PIO, o/o the DFO, Lohit Forest Division, Tezu.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bagemso Mitti for non-furnishing of 29(twenty nine) point information on Model Nursery Project under CAMPA 2023-24, Located under Digaru Forest Range, Lohit Forest Division by the PIO, o/o the DFO, Lohit Forest Division, Tezu, Lohit District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 28.11.2025.

This appeal is listed for 2nd time today on 11.09.2026, the 1st time being on 24.07.2026 when both the appellant, Shri Bagemso Mitti and the PIO, Shri Aduk Paron attended through VC.

This Commission, after hearing the parties and upon perusal of the records, had directed the appellant, vide order dt.24.07.26, to collect the information/documents from the o/o the PIO, as advised by the PIO, within 1(one) week from the date of receipt of Commission's order dt.24.07.26 and report the short coming, if any, therein to this Commission within 1(one) week of the receipt of the same for further consideration of the appeal, if so warrants.

The appellant, in compliance with this Commission's order, had collected the documents from the office of the PIO but vide his letter dt.30.07.2026, complained that the PIO either furnished misleading information /replies or did not furnish complete information.

This Commission carefully examined the shortcomings complained by the appellant as above vis-à-vis the replies / information furnished by the PIO, vide forwarding letter dt. 12.06.26 and directed the PIO to furnish the revised and corrected information to the appellant within 3 (three) weeks from the date of receipt of this order dt. 18.08.2026 and report compliance thereof today on 11.09.2026.

Today also both the appellant and the PIO are present through VC.

Heard the parties.

The PIO submitted that in compliance with this Commission's order dt.18.08.2026, the revised replies/information has been furnished to the appellant vide letter dt. 02/09/2026 the receipt of which the appellant has duly acknowledged.
