Information sought:

The appellant filed an RTI application dated 16.06.2025 seeking following information pertaining to frontier highway, Huri-Taliha stretch (package-III), by BRO.

Details of information required:

1. Furnish land acquisition owner name.
2. Furnish bill amount 1/1 owner name with details e.g. cardamom garden, bamboo & jhum cultivation etc.
3. Furnish rate of frontier highway per sqr/ per meter/ per foot.
4. Cheque Xerox copy of details.
5. Furnish the total project amount of frontier highway (package-III) by BRO, Huri Taliha.

The following were present.

Appellant

: Present. He states that the information furnished by the PIO is not complete. The PIO has not furnished the information at serial no. (ii) & (iv) of his RTI application.

Respondent PIO : Absent. Shri Jumdo Karbak (Mandal) has represented the PIO. He has brought a written submission from the PIO.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that some information was already furnished to the appellant earlier and today the representative of PIO has brought a written submission from the PIO contesting the balance information. The copy of information submitted by the representative of PIO be given to the appellant for his acceptance or counter argument by filing in written to this commission. The appellant is directed to file a written submission on status of the information document furnished and written statement filed today by the PIO to this commission within two weeks from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant. In case no compliance report is received at commission from the appellant within stipulated time, this appeal case shall stand closed.
