Information sought:

The appellant filed RTI application dated 11.07.2025 seeking following information regarding the supply of materials (non wages) under MGNREGA scheme, Lekang, Namsai district, Arunachal Pradesh.

Furnish certified copies of: -

- Detail project report.
- Tender notice/board notice and newspaper clipping where it was published.
- Technical sanction and technical order.
- Names of firms participated in the tendering process along with their submitted documents, viz, firm registration certificate, GST registration, trade licence, pan cards, financial documents, etc.
- Name of firm who qualified in the tender bidding process.
- Comparative statement of financial bids.
- Measurement book.
- Purchase order/ work order/supply order and bill issued to vendors for supply of materials.
- Material receipt/stock register showing receipt of materials with quantity, date and supplied details.

- j. Vouchers copies /bills submitted by vendors.
- k. Quantity check reports/inspection reports from the monitoring unit.
- l. Photograph of before, during and after work execution.
- m. Material purchased register.
- n. Stock consumption register.
- o. Material stock register.
- p. Material handover certificate/acknowledgement receipt.
- q. Photographic evidence of the work progress in colour.
- r. Social audit reports/vigilance findings/audit report.
- s. Utilization report showing how and where the materials were used and.
- t. Payment acknowledgment /cheque copies/NEFT details payment made through public financial management or account payee cheque to the contractor firm.

The following were present.

Appellant : Present through VC. He states that the information furnished by the PIO is incomplete.

Respondent PIO : Present through VC. He states that all the information has been already furnished to the appellant. However, some information is in official website which is in public domain.

On interjection both the PIO and appellant states that the First Appellate Authority has heard their case on 25.9.2025 but the appellant said he has not received the judgement order copy. The PIO produced the said judgement order and copy given to the appellant.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that this is a on-going appeal case with First Appellate Authority (FAA) which is not yet disposed off at his level.

Now Therefore, the instant appeal case is again remanded to First Appellate Authority. Therefore, the **FAA- Additional Deputy Commissioner cum Project Director**, Lekang Block, Namsai District, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order.

The appellant is at liberty to approach this commission:

1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
2. If the FAA has denied the requested information based on specific exemptions/ grounds provided under the RTI Act, 2005.
