An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-813/2025

Shri Tamchi Gungte -V/S- PIO-Cum-DFO, Bomdila, West Kameng District A.P.

ORDER

The 1st hearing held on 24th **March'2026** related to the **APIC No-813/2025**. The Appellant Shri Tamchi Gungte, present during the hearing and the PIO-cum DFO Bomdila West Kameng District, represented by Shri Gollo Nera with an authorization letter from the PIO.

Heard the Appellant;

The Appellant stated before the Commission that some of the information as applied in his form 'A' have been furnished to him but the majority of the information have not been provided to him by the PIO. The information listed under Sl.No 1-9 have been only provided to him till today.

Heard the APIO.

The APIO stated before the Commission that the information applied by the Appellant pertains to the works executed by the Khufi Range.

Therefore, the PIO has written to the Range Forest Officer (RFO) Khufi to provide information to him so that he can provide the same to the Appellant but due to transfer of the incumbent RFO, the new RFO could not provide the information till now to the PIO, and hence this delay to provide the information to the Appellant. But I assure to provide the information within 1(one) from today.

After hearing both the parties the Commission hereby observes;

In the present time that is last part of Financial Year (FY) all the Govt. Departments can be well understood for their busy schedule and considering this, the Commission hereby grants the request of APIO to give them 1(one) moth time to provide complete information to the Appellant and by these observations and consideration the Commission hereby pass the below orders;

- i) The PIO to provide the remaining information to the Appellant within 1(one) month from today without fail and PIO to be present in the next date of hearing without fail, **falling which appropriate action shall be imitated against the PIO as per the provisions of the RTI Act 2005.**

- ii) The Appellant to pursue the information from the PIO and to be present in the next date of hearing without fail, **failing which his appeal shall be heard and determined ex-parte.**
- iii) The next date of hearing has been intimated to the both the parties. Notice need not be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 9th June 2026 at 2:30 PM (Evening).
