## CHAPTER-1

### INTRODUCTION

The Parliament of India enacted the Right to Information Act, 2005 which received the assent of the President of India on 15.06.2005. While some provisions of the Act came into force at once, some others came into effect on the one hundred and fiftieth day of its enactment.

The basic objective of the Right to Information Act is to empower the citizens, promote transparency and accountability in the working of the Government, contain corruption and make Indian democracy work for the people in real sense. The Act is a big step towards the citizens informed about the activities of the Government.

The Right to Information Act has a comprehensive reach and covers a wide spectrum of bodies. All the Departments and undertakings of the Central and State Governments, institutions, agencies and other bodies established, constituted, owned, controlled or substantially financed by Governments including non-governmental organizations come under the Act. Every citizen of India has the right to information accessible under the Act which is held by or under the control of any public authority. Such accessible information includes inspection of documents or records, taking certified samples of material, cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device.

As provided under section 15 (1) of The Right to Information Act, 2005, the Governor of Arunachal Pradesh constituted the Arunachal Pradesh Information Commission vide Notification No. OM-51/2005 dated 13.10.2006 with 1 (one) Chief Information Commissioner and 3 (three) Information Commissioners with immediate effect. The Commission started functioning with immediate effect with Shri Nyodek Yonggam as Chief Information Commissioner and Shri Bani Danggen, Shri Habung Payeng, Shri Nipo Nabam, as Information Commissioners.

In exercise of the powers conferred by the Section 15 of the Right to Information Act, 2005 (No.22 of 2005) and in partial modification of the Notification No. OM-51/2005 dated 13.10.2006, the Governor of Arunachal Pradesh constituted the Arunachal Pradesh Information Commission with a Chief Information Commissioner and 4(four) Information Commissioners with immediate effect vide Notification No. OM-51/2005/396 dated 14.11.2007 and subsequently appointed Shri Toko Anil as State Information Commissioner in the Arunachal Pradesh Information Commission vide Notification No.OM-51/2005/396 dated 14.11.2007. Shri Toko Anil assumed office of the State Information Commissioner on 03/12/2012.

Shri Nyodek Yonggam demitted office of the Chief Information Commissioner on 28.02.2011 on attaining the age of 65 years as per section 16 (1) of the Right to Information Act, 2005. In his place Shri Y.D.Thongchi, IAS (retd.) was appointed as the State Chief Information Commissioner vide Notification No.AR-O2/2011 dated the 9<sup>th</sup> March, 2011.

Shri Bani Danggen, Shri Habung Payeng, and Shri Nipo Nabam demitted office of the Information Commissioner on 19.10.2011 on completion of 5 (five) years of service as per section 16 (2) of the Right to Information Act, 2005.

Shri Toko Anil demitted office on 02.12.2012 on completion of 5 (five) years of service as per section 16 (2) of the Right to Information Act, 2005.

Now the Arunachal Pradesh Information is manned by Shri Y.D.Thongchi, IAS (Retd.) Chief Information Commissioner alone.

Section 25 of the Right to Information Act provides that the Central Information Commission or the State Information Commission shall prepare a report on the implementations of the provisions of the Act after the end of each year and forward the report to the appropriate Government for laying it before the Parliament or the State Legislature. But except an annual report of 2008, the Arunachal Pradesh Information Commission could not publish annual report due to inadequate staff. However, this combined annual report has been prepared in compliance with sub-section 25 sub-section (1) of the Right to Information Act.

The Arunachal Pradesh Information Commission is pleased to present its combined Annual Report covering the period from October, 2006 to December, 2012 which has been prepared after compiling all the required Information received from different Public Authorities in whole of Arunachal Pradesh.

## CHAPTER- 2

### **A brief about Arunachal Pradesh Information Commission.**

The Right to Information Act , 2005 came into force in Arunachal Pradesh along with the rest of the country on 12<sup>th</sup> October, 2005 after 120 days of its enactment. As per the provisions of this Act, State Public Information Officers (SPIO) and State Assistant Public Information Officers (SAPIO) were appointed by the Government of Arunachal Pradesh with separate notifications. In pursuant to the provisions of Clause 3 Section 15 of the Right to Information Act, a selection committee was constituted for the appointment of State Chief Information Commissioner and State Information Commissioners. On 13/10/2006, Arunachal Pradesh Information Commission (APIC) was constituted and appointed Shri Nyodek Yonggam as the State Chief Information Commissioner and Shri Bani Danggen, Shri Habung Payeng and Shri Nipo Nabam were appointed as State Information Commissioners. They were administered the oath of office by his Excellency, The Governor of Arunachal Pradesh, on 19/10/2006.

Further a fresh selection committee was constituted in proviso of Clause (3) of Section 15 of the Right to Information Act, 2005 in a separate notification dated 18<sup>th</sup> October, 2007 and Shri Toko Anil was appointed as State Information Commissioner on 14/11/2007. He was administered the oath of office by State Chief Information Commissioner, Arunachal Pradesh, on behalf of His Excellency, the Governor of Arunachal Pradesh, on 3/12/2007.

Due to its new establishment, the Commission took some time to start its functioning. The Commission started functioning after getting office accommodation at Secretariat Annexe building in the first week of December, 2006 with office functionaries provided by the State Government. The Commission, thereafter, entertained complaints and appeals and initiated proceedings to dispose them off. It has also started monitoring the implementation of RTI Act and issued necessary instructions to various departments to comply with the provisions of RTI Act. The Commission is looking forward to educate the public and officials for proper implementation of RTI Act with the help of the State Government. Due to dismantling of the state Civil Secretariat for construction of new buildings the Arunachal Pradesh Information Commission was shifted to Hotel Bomdila on 5<sup>th</sup> November, 2008. The Commission is still functioning from the same place.

**COMMISSION'S ROLE ON THE IMPLEMENTING RTI ACT :** The Section 18 of the Act prescribes that Information Commission shall receive and enquire into a complaint from any person in respect of any matter relating to requesting or obtaining access to the records under the Act. It also empowers the Commission, during the enquiry of any complaint under the Act, to examine any record to which this Act applies under the control of public authority and no such record may be held on any ground.

Section 19 mandates that the decision of the State Information Commission shall be binding. Further, the Information Commission, while deciding appeals can require a public authority to take any such steps as may be necessary to secure compliance with the provisions of the Act. Section 19 further mandates that while deciding appeals, the Information Commission is competent to impose any of the penalties under this Act.

Section 20, empowers the Commission to impose penalty, at the time of deciding any complaint appeal if it is of the opinion that the SPIO has without any reasonable cause refused to receive an application for information or has not furnished the information within the time specified under Sub-Section (1) Section 7 or malafidely denied the request for information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of Rs. 250 each day till application received or information is furnished. However, the total amount of such penalty shall not exceed Rs. 25000/-.

Under Section 23 of the Act no court shall entertain any suit, application or other proceedings in respect of any order made under this Act, and no such order shall be called in question otherwise than by way of an appeal under this Act.

Section 25, clause 3 (g) mandates that the State Information Commission shall state the recommendation in respect of the particular public authority, for development, improvement, modernization, reform or amendment to this Act or other legislation or common law or any other matter relevant for operationalising the Right to access to information.

The various provisions relating to Information Commission under the RTI Act, 2005 place a onerous responsibility on the Commission towards the establishment of a practical regime of Right to Information for citizens and promotion of transparency and accountability in the working of public authorities in the State.

#### **ACTIVITIES UNDERTAKEN BY THE COMMISSION DURING THE REPORTING PERIOD:**

The Arunachal Pradesh Information Commission has been taking a proactive role-vis-à-vis the state administration in pursuing the implementation of RTI Act, 2005 at all levels. Towards this pursuit, the State Information Commissioners had visited almost all districts in the state and had held interactions and meetings with the PIOs/APIOs/Appellate officers, members of NGOs and common citizens. The Commission had also held meeting with the Hon'ble Chief Ministers, the Chief Secretary and other Commissioners and Secretaries on implementation of RTI Act in the state. The State Information Commissioners also attended Central Information Commissioners' conference in New Delhi held on 17.10.2007. Further the State Information Commissioners visited few states to study the functioning of State Information Commission and the implementation of the RTI Act.

## CHAPTER-3

### IMPLEMENTATION OF RIGHT TO INFORMATION ACT, 2005 IN ARUNACAHAL PRADESH

#### 1. RULES FRAMED UNDER THE RTI ACT, 2005 :

(A) For smooth and effective implementation of the provisions of the RTI Act the Arunachal Pradesh State Government has framed the Arunachal Pradesh Right to Information Rules, 2005 and notified it vide No.OM-43/2003 dated 15/09/2005. And subsequently made two amendments vide notification No. OM-73/2005 dated 15/05/2006 and 01/05/2007.

(B) Under Section 27 (2) (e) of the RTI Act, 2005 the Arunachal Pradesh Information Commission (Appeal Procedure) Rules, 2005 has been notified on 24/11/2005.

**2. SUO-MOTO DISCLOSURE OF INFORMATION :** Section 4 of the RTI Act, 2005 provides for proactive disclosure of information by the public authorities within 120 days from enactment of this Act. So far the progress of this provision in the State is not found satisfactory. The Commission is in constant touch with the public authorities to comply with these statutory provisions. All the public authorities have been instructed to comply with this provision of the Act in the local newspapers.

**3. APPOINTMENT OF STATE INFORMATION OFFICERS :** Under Section 5 (1) every public authority shall within 100 days from the enactment of this Act designate the required number of officers in the administrative units under it as State Public Information Officers who are to provide information under the provision of this Act and under Section 5 (2) the Public authorities shall designate within 100 days of enactment of this Act, the SAPIO at each sub-division centre or other sub-district level functioning under their control so as to receive the applications and forward the same to the SPIO or Appellate authority.

In compliance with the above provisions of the Act appointment of Information Officers have been made in the state as under.

- (a) **PUBLIC INFORMATION OFFICER :** 363 PIOs have been appointed covering all public authorities and Autonomous bodies etc all over the State as per the record available.
- (b) **ASSISTANT PUBLIC INFORMATION OFFICER (APIO) :** All the Circle and Sub Division level officers of all the department have been appointed as APIOs in the State.
- (c) **FIRST APPELATE OFFICER :** All the officers senior in rank to the PIOs in a given public authority have been appointed as Appellate Authority U/S 19(1) of the RTI Act, 2005 to hear appeals of citizens who are aggrieved of the decision/action of the PIOs regarding.


#### **CITATION**

**CHAPTER-5****Commission's Observation and Recommendations:-**

1. It has been observed that the implementation of the provision pertaining to disclosure as mentioned U/S 4 (1) (b) of the RTI Act has not been satisfactory. The State Government should therefore, take necessary steps to ensure the voluntary disclosure of information by the Public Authorities.
2. Designation of PIOs, APIOs and Appellant Authorities by various public authorities U/S 5 and 19 of the Act is satisfactory to some extent. It is suggested that all the public authorities should appoint more PIOs, APIOs and Appellant Authorities as required.
3. It has been noticed that the lists of PIOs, APIOs, and Appellate Authorities have not been displayed in notice board by the Public Authorities. Therefore, the information seekers used to visit the office of the State Information Commission to know the names of PIOs and APIOs for filling application and to obtain application forms under the Act. The Public Authorities should therefore, ensure that the complete details of the designated PIOs, APIOs and Public Authorities are made available for information seekers.
4. The Commission observed that the Public Authorities are not submitting periodical returns and reports to the nodal department of the State Government and the State Information Commission. For this purpose, the Public Authorities must collect information in prescribed format from PIOs and APIOs located in various places of public office and submit the return and reports in stipulated time.
5. Section 26 of the RTI Act, 2005 delegates responsibilities on the State Government for propagating various provisions of the Act among the Citizens. However not much have been done so far in this regard during the reporting period. It is the duty of the State Government to develop and organize educational programme to advance the understanding of the policy in particular for the disadvantaged Community as to how to exercise the rights contemplated under this Act. Adequate budget needs to be provided to the State Information Commission or Nodal department to conduct extensive educational programme for the information seekers and training programme for information givers i.e. PIOs and public Authorities. During the financial year 2007-08, the ATI and SIRD had organized State level Training of Trainers programmes on 'Capacity Building for Access to Information' under the financial Assistance of Department of Personnel and Training (DOPT), Government of India. The Administrative Training Institute (ATI), Naharlagun has been imparting training on RTI Act, 2005 to PIO's and APIO's from time to time. Under UNDP's project at Naharlagun on

1<sup>st</sup> October, 2007 where a few Appellant Authorities and PIOs of two districts, viz- West Kameng and Lohit were given training on RTI Act, 2005. Again sensitization training programme on RTI Act for PIO's and APIO's was conducted by Administrative Training Initiative Naharlagun from 4<sup>th</sup> March to 6<sup>th</sup> March 2013. The State Government is therefore, requested to provide funds to ATI, SIRD, NGOs and the State Information Commission to enable them to organize educational programmes on RTI Act, 2005 at various levels.

6. The PIOs have additional responsibilities and duties to carry out the implementation of the RTI Act, apart from their normal official works. Therefore, it is necessary to provide them with additional infrastructure and extra remuneration.
7. The Commission observed that the State Information Commission should have financial autonomy at par with other states in the country so that the Commission need not go to the Finance department or the concerned administrative department for fund. Fund is also needed to meet administrative expenditure like providing brochures, photo copies and expenditure for pro active display of information. It is therefore, suggested that the State Government should provide financial support to the Commission in the form of Grants-in-aid with charged budget.
8. So far some officials in the Commission including the Registrar-cum-Secretary, Deputy Registrar, etc. are working in addition to their portfolios in other department as a stop gap arrangement. In such a situation officer is unable to do justice to both the department and as such normal working process is hampered. On the other hand staff in the Commission is also posted from the general administration. Due to non direct administrative control on the staff by the Commission, the normal working process is adversely hampered. It is recommended that the post of all necessary staff be created immediately so that staffs could work and devote for the Commission's duty efficiently.
9. Considering the autonomous status of the Commission under the Act, the State Information Commission should be allowed to have autonomy in matters related to creation of posts and recruitment of the staffs and officials as per section 16 (6) of the Act.
10. The Commission has observed that proper terms and conditions of services of State Chief Information Commissioner and State Information Commissioners have not yet been properly maintained by the State Government as per section 16 (5) of RTI Act, 2005. It is an established fact that anybody in the public service having no such

proper terms and conditions of service would face difficult to maintain their true status in carrying out their duties and responsibilities. Therefore, the State Government is suggested to take appropriate steps in this connection in the line of other states.

Further, order of precedence of the State Chief Information Commissioner and the State Information Commissioners may also be specified.

11. The Court and office of the commission is presently located at some rented rooms in Hotel Bomdila Complex. Due to this reason the Sanctity and decorum of the court during hearing could not be maintained. Moreover no police guard is provided to the commissions office and at the court room to maintain law and order problem during hearing of complaint and appeal. Therefore state government should either provide fund for construction of commissions building or suitable accommodation should be provided at the new secretariat building.
12. Residential accommodation is also not provided to some Commissioners so far even after more than 5(five) years of creation of the commission. It is learnt that the suitable accommodation could not be provided due to paucity of government accommodation. Therefore, State government is requested to provide reasonable house rent to those who has not been provided with such residential accommodation as per their rank and status. In some states the Commissioners are paid Rs. 16,000 per month in lieu of government accommodation.
13. The State Information Commissioners are also not provided staff car of its own. Old cars from the Secretariat pool are provided to the Commissioners on temporary basis. The vehicles are to be repaired frequently and are not fit to go on tour. The Commission has proposed either to sanction for procurement of new vehicles or provide Rs. 18,000 (Rupees Eighteen Thousand) only per month in lieu of staff car as practiced in some states. Paying Rs. 18,000 per month in lieu of staff car will be more economical as it includes fuel and driver salary except journey beyond 30 kms form the headquarters. It is recommended for appropriate action.

1. This is a continuation of the hearing of the same appeal of 8-1-2007. During the hearing today. The Dy. Secy. (Edu.) produced a letter sent from the Education Deptt. To the Commissioner (AR) for designating the DDSEs as PIOs in compliance of the order of the Commission. The Commission then asked each of the DDSEs individually as to why the information sought by the complainant was not furnished by them through the PIO in time. The PIO clarified that only DDSE Seppa and DDSE Changlang had furnished some information to him. All the DDSEs present submitted either that they were ignorant of the RTI Act or the steps to be taken by them as deemed PIOs or that they received the intimation from the PIO after sufficient delay.
2. All the DDSEs except Aalo, Daporijo and Koloriang furnished the documents to the complainant during the proceedings. DDSE Daporijo undertook to furnish the information by evening as he had brought the original records only. The DDSE Aalo and DDSE Koloriang were given time of two weeks and one month respectively as desired by them to furnish the information.
3. The Commission observed that ignorance of Law is no excuse and it was the responsibility of the PIO and the deemed PIOs to furnish the information in time. The Complainant also requested the Commission for appropriate action as enough delay had occurred. After detailed discussion, the following directions are issued till the next date of hearing on 6/2/2007.
  - (i) The complainant Dr. A. Riddi had appealed to the Director (School Education) on 15/11/2006 but there was no response from the DSE till the stipulated time of 30 days i.e. 14/12/2006 which forced the complainant to file the second appeal with the Commission. **As the DSE being the appellate authority has failed to respond and take action, the Director of School Education Smt. K. Namshoom is asked to show cause by 6/2/2007 as to why a sum of Rs. 6500 being penalty for 30 days @ Rs. 250 per day should not be imposed against her.**
  - (ii) The PIO cum Joint Director (SE) Shri K. Yirang received the application in Form A on 7/8/2006. As the information sought was not with him, he should have informed the applicant in Form B within 5 days i.e. before 12/8/2006. But he has written to the DDSEs to furnish information only on 8/9/2006 i.e. after a gap of 25 days. **So the Lt. DSE & PIO Shri K. Yirang is asked to show cause by 6/2/2007 as to why a sum of Rs. 6250 being penalty for 25 days @ Rs. 250 per day should not be imposed against him.**
  - (iii) From the record, all the DDSEs concerned were asked by the PIO on 8/9/2006, 16/10/2006, 24/11/2006 and 6/12/2006 to submit the information sought by the complainant. During the meeting of DDSEs held on 14/10/2006 at Itanagar to

discuss SSA matters also, the PIO asked them verbally to submit the information. The DDSEs and the NO/SPD SSA failed to respond even though they are deemed PIOs under section 5 (4) and 5 (5) of the RTI Act and thereby violated the provision of the Act. **Therefore each of the DDSEs mentioned above and present are asked to show cause by 6/2/2007 as to why a sum of Rs. 15000 each being penalty for 60 days @ Rs. 250 per day (From 8/9/2006 to 12/12/2006 excluding grace period of 35 days) should not be imposed against each of them.**

(iv) The SPD and Nodal Officer of SSA failed to respond to the letter written from the PIO (Jt.DSE) on 18/10/2006 for nomination of PIO for SSA matters. They also defied the Summons from the Commission for hearing on 8/1/2007 by absenting themselves in spite of due intimation. **So Shri E. Lego, Nodal Officer, SSA and Shri P.N. Thungon, State Project Director, SSA are directed to show cause by 6/2/2007 as to why their names should not be recommended for disciplinary action under the CCS(CCA) Rules.**

**ORDER**

1. This is an appeal under the Right to Information Act, 2006 (hereinafter called the Act) filed by Shri Sange Norbu against the PIO and Under Secretary Shri N. Tondrang of the Arunachal Pradesh Public Service Commission ( hereinafter 'the APPSC') on 30-3-2007 for failure to allow inspection of answer scripts of the Inspector of Tax & Excise exam.
2. The applicant had applied on 15-1-2007 to the PIO cum Under Secretary of the APPSC to allow inspection of his own answer script of mathematics of the Inspector of Tax and Excise Exam held in 2005 and conducted by the APPSC. The PIO vide his reply No. PSC-R/06/2006 dated 9/2/2007 replied to the applicant stating that as the Hon'ble High Court of Karnataka in its interim order has stayed the supply of any copy of answer script in writ petition No.1/935/2006 (GM-RES) Karnataka Public Service Commission (Petitioner) – Vs- Shri Rama Murthy (Respondent). The APPSC will communicate its decision to him based on the final outcome of the Karnataka High Court verdict. But the applicant/appellant herein contended through records that in a similar application submitted by Shri Tageng Pado (Advocate) for inspection of answer script of APPSC (Main) Exam. 2002 wherein one Dr. Taking Gammi appeared, the Commission allowed the applicant to inspect the answer script

through letter No.PSC-R/06/2006 dated 23/2/2007. As the PIO did not allow his prayer but allowed that of someone else in a similar case. The applicant/Appellant has filed this appeal before the Commission.

1. During the first hearing on 16-4-2007, the PIO was present along with the Secretary of the APPSC Shri N. Mali and Shri Y. Nijo, UDC. After hearing detailed oral submissions from both sides, the Commission directed the APPSC to furnish written replies/ submissions by 20-4-2007. On 20-4-2007, again detailed arguments were heard.
2. In the written submissions, the APPSC detailed the sequence as to how the application for perusal of answer scripts by Dr. Taking Gammi was allowed while the case of applicant was rejected. The APPSC further argued that the functions of the APPSC are guided by the APPSC (Limitation of Functions) Regulation, 1988 amended from time to time and in that there is no provision for supply and inspection of copies of answer script except for furnishing of mark sheets on payment of Rs. 25 by IPO. Disclosure of answer scripts of any competitive exam conducted by the APPSC will prejudicially affect the impartial and autonomous status of the APPSC as the answer scripts are top secret documents. Section 8(I)(j) of the Act exempts disclosure of such top secret information if it has no relationship to any larger public activities or interest. The APPSC has a fiduciary relationship with the examiner who evaluated the answer scripts and the disclosure of these is exempted under Section 8(I)(e) of the Act. They submitted that in the case of Tressa Irish of Kerala Postal Circle in a case for disclosure of evaluated answer scripts, the Central Information Commission rejected the request and up held the order of the CPIO. In that case it was held that evaluated answer scripts available with the public authority were in his fiduciary relationship, the disclosure of which were exempted under section 8(I) (e) and also when a candidate seeks evaluated answer scripts either of his own or others, it was purely personal information, the disclosure of which has no relation to any public interest or activity and such was exempted under section 8(I) (j). Similarly, the Maharashtra State Information Commission in the appeal of Deepali M. Hodge -Vs - Registrar, Pune University rejected the request for copies of answer scripts. Further when the APPSC allowed the case of Dr. Taking Gammi, the information was misused and adverse comments were made by him in the print media. So the APPSC felt that furnishing of such information is not in the interest of any larger public service or activity. Under these circumstances, the APPSC dismissed the application filed by the applicant and prayed to the Commission to dismiss the appeal.
3. Form the records and perusal of the documents and submissions in this case and the relevant sections of the Act, the following are pertinent :-
  - (i) The contention of APPSC as to their answer scripts being so secret as to be covered under the Official Secrets Act, 1923 does not hold ground in view of section 22 of the RTI Act, 2005. The answer script of the candidates may be top secret and confidential before the exam result is declared but ceases to be so as soon as the results are declared.

- (ii) Section 8(I) (e) is not attracted as the answer scripts having been examined by an examiner are owned by APPSC. APPSC is not a mere custodian/keeper of these scripts but is the owner.
- (iii) The APPSC is a public authority and conducts examinations for selection to various posts in the State Government Public interest mandates that this is done in a fair and transparent manner for large public good that and also to clear away the doubts about fairness. Allowing perusal of one's own answer script will raise the stature of the APPSC in the eyes of the general public as to its fairness and impartiality. So although the information sought is personal, larger public interest justifies the disclosure of such information. Therefore section 8(I) (j) is also not attracted.
- (iv) Section 8(2) also clarifies that notwithstanding anything in the Official Secrets Act, 1923 nor any of the exemptions permissible in accordance with sub-section (I), a public authority may allow access to information, if public interest justifies the disclosure of such information. Therefore section 8(I) (j) is also not attracted.
- (v) The judgments and orders of various State Information Commissions disallowing access to written answer scripts quoted by the APPSC is only one side of the coin. There are also orders of other State Information Commissions allowing perusal of answer scripts.
- (vi) In the present case, the moot point is the applicant has not asked for copies of his answer scripts. Neither has he asked for name (s) of the examiner who evaluated his script nor for answer scripts of other candidates. If he had applies for copies of the answer script of his or that of other candidates, the issue would have been different. He has only asked to peruse his own answer script for personal reasons. It is pertinent to note that in the case of Dr. Taking Gammi, not only did the APPSC allow perusal by the candidate of his own answer script but those of all other 84 selected candidates of the APPSCCE (Main) Exam 2002-03. Parity and fairness deserves that the applicant herein is allowed to peruse his own answer script. The APPSC cannot act in an arbitrary manner by allowing some and disallowing others when the circumstances are identical. Nothing will be gained by the APPSC by concealing this but allowing perusal will lead to more transparency of the procedure without jeopardizing the examination process and the safety and security of evaluators.

4. In view of the above, the Commission is of the firm view that the APPSC needs to allow the applicant to allow perusal of his mathematics answer script of the Inspector (Tax and Excise) Exam. The Secretary, APPSC is directed to comply with this order and allow the applicant Shri Sange Norbu to peruse the answer scripts within a month from today.

## JUDGMENT & ORDER ( CAV )

- (1) Arunachal Pradesh Public Service Commission for short, (APPSC) feeling irritated by the decision passed by the Arunachal Pradesh Information Commission rendered in case No.APIC/14/02 on 26/4/07 directing them to allow the applicant/ Respondent No. 2 for perusal of his answer script of Mathematics paper where he appeared in the test conducted to select candidate for appointment in the post of Inspector (Tax & Excise), has approached this Court by filing this writ petition.
- (2) I have heard Mr. N. Tagia, learned Standing Counsel for the APPSC and Mr. T. Partin, learned counsel appearing for Respondent No. 1. None appears on behalf of Respondent No. 2 applicant at the time of hearing.
- (3) The applicant/ Respondent No. 2 appeared in a competitive examination being an aspirant for the post of Inspector (Tax & Excise) conducted by the APPSC. The Respondent No. 2 not being satisfied with the evaluation of his answer script in Mathematics paper, he applied for perusal and inspection of the answer script by filing necessary statutory application in Form-A under the Right to Information Act (hereinafter referred to as the Act) to the Public Information Officer of the Commission complying with the necessary requirements. Vide communication dated 9/2/2007; the Public Information Officer of the Commission refused his prayer. Being aggrieved, the applicant filed an appeal on 30/3/2007 before the Chief Information Commissioner of the State Information Commission constituted under the Act. The appellate authority after hearing the parties, vide impugned judgment and order dated 26/4/07 allowed the appeal and directed the APPSC to allow the applicant for perusal of his Mathematics answer script as prayed for, within a period of 1 month. The said decision is challenged by the APPSC in this writ petition.
- (4) Mr. N. Tagia, learned Standing Counsel for the APPSC contends that the disclosure of answer script in question so examined by the specific examiner appointed by the Commission constituted a fiduciary relationship and in the event of disclosing the same to the applicant, it would be violative of such relationship that exists between the commission and the related examiner which attracts the exemption contained in Section 8(1) (c) of the Act and such fiduciary relationship is required to be maintained for larger public interest. It is also contended by the learned Standing Counsel that the Information sought for being the personal information about the performance of the applicant, there is no involvement of any public interest and as such the commission has no obligation to allow the applicant to peruse the answer script. Under Section 8 (I) (j) of the Act.

Learned Standing Counsel press into service the decision of the Apex Court rendered in Maharashtra Board of Higher Secondary Education Council – Vs – Paritosh reported in

AIR 1984 SC 1534 and some other unreported decisions rendered by the Kerala State Commission and by the Central Information Commission, and such other commission, but the text of the judgments have not produced before the Court.

Referring to the aforesaid decisions, learned Standing Counsel contends that in the event of allowing the prayer of the applicant there would be delay in attaining the finality of the examination process and it will be against the norms of public policy. It is further contended that the APPSC is guided and regulated by the Arunachal Pradesh Public Service Commission ( Limitations and Functions) Regulation, 1988 and in the matter of conducting the competitive examination, the regulation do not contain any such provisions for supply/ inspection of the answer script to a candidate. It is further contended that the impugned judgment not having disclosed the nature of public interest involved in the matter, the same is a cryptic one without disclosing the mind of the authority and accordingly the same is liable to be interfered with.

- (5) Mr. T. Pertin, learned counsel appearing for the respondent/ the State Information Commission per contra contends that the applicant has got existing right to receive the 'information' with the meaning of Clause -2 (j) of the Act and the APPSC being a public authority and State within the meaning of Article 12 of the Constitution of India has got an obligation under Section 4 of the Act to provide such information to the applicant by allowing him to peruse the answer script and by refusing to do so, the APPSC has violated the provisions of the Act and also has violated the existing right of the applicant. It is also contended that on earlier occasion such inspection of answer script in respect of Civil Service Examination conducted by the APPSC in the year 2002 was allowed to one Dr. Taken Gammi and as such the APPSC is not permitted to take a different stand in case of the applicant.
- (6) The Right to Information Act, 2005 was enacted by the Parliament in order to ensure greater and more effective access to information repealing the Freedom of Information Act, 2002 which was holding the field till then. The preamble of the Act reads as follows :

"WHEREAS the Constitution of India has established democratic Republic;

AND WHEREAS democracy requires an informed citizen and transparency of Information which are vital to its functioning and also to contain corruption and to hold Governments and their instrumentalities accountable to the governed;

AND WHEREAS revelation of information in actual practice is likely to conflict with other public interests including efficient operations of the Governments, optimum use of limited fiscal resources and the preservation of confidentiality of sensitive information;

AND WHEREAS it is necessary to harmonise these conflicting interests while preserving the paramountcy of the democratic ideal;

NOW, THEREFORE, it is expedient to provide for furnishing certain information to citizens who desire to have it."

Section 2(f) of the Act defines "information" as any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form, which can be accessed by a public authority under any law for the time being in force.

**Section 2 (h) defines 'public authority'**

Section 2 (j) defines "**right to information**" which also includes inspection of all documents and records.

Section 4 of the Act makes it obligatory upon the public authority for maintaining necessary records.

The Right to Information has been guaranteed by the Act to all citizens of the country. The Act can be aptly described as statutory recognition of the segments of right to information emanated from Article 19(a) of the Constitution of India in statutory form.

Under the Act the transparency in the administrative functions of the various organs of the Government has been sought to be made available to the public. Whether in the matter of public administration be it in the form of adjudication of rights of citizens or in the matter of infrastructure building of the State, or otherwise transparency of the actions of the public authority has become an order of the day. The very objective of the Act is to allow the citizens to scrutiny the Governmental action within the parameter of the Act to ensure accountability and transparency in Governmental functions. However, Section 8 of the Act provides certain restrictions in the form of exemption.

- (7) In the light of the broad scope of the Act let me examine whether the stand of the APPSC as raised during the course of argument resisting the order passed by the State Information Commission is sustainable within the touchstone of the provisions of the Act vis-à-vis the APPSC regulations.
- (8) The exemption clause as reflected in Section 8(I)(a) and (j) of the Act which are pressed in to service by the APPSC are as follows:

"Section-8. Exemption from disclosure of information – (I) Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen.-

- (a) Information, disclosure of which would prejudicially effect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence;
- (j) information which relates to personal information the disclosure of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justified the disclosure of such information;

(9) **The fiduciary relationship has not defined under the Act. The term 'fiduciary' in Jowett's Dictionary of English Law, 2nd Edition, Vol-1, page- 788, is defined as follows:**

"Fiduciary:-One who holds anything in trust. A person is said to stand in a fiduciary relation to another when he has rights and powers which he is bound to exercise for the benefit of that other. Hence he is not allowed to derive any profit or advantage from the relation between them, except with the knowledge and consent of the other person. Such is the relation between trustee and cestui que trust, solicitor and client, principal and agent, and generally wherever from the position of two persons, one of them reposes confidence in the other. Promoters and directors also stand in a fiduciary relation to their companies.

(10) **Black's Law Dictionary, 7<sup>th</sup> Edition, page-6-10, defines the term 'fiduciary' and 'fiduciary relationship' as follows:**

"Fiduciary: - 1. One who owes to another the duties of good faith, trust, confidence and candor (the corporate officer is a fiduciary to the shareholders). 2. One who must exercise a high standard of care in managing another's money or property (the beneficiary sued the fiduciary for investing in speculative security)

"Fiduciary relationship: - A relationship in which one person is under a duty to act for the benefit of the other on matters within the scope of the relationship. Fiduciary relationships such as trusts beneficiary, guardian- ward, agent-principal and attorney- client require the highest duty of care. Fiduciary relationship arises in one of four the situations; (1) when one person places trust in the faithful integrity of another, who as a result gains superiority nor influence over the first, (2) when one person assumes control and responsibility over another, (3) when one person has a duty to act for or give advice to another on matters falling within the scope of the relationship, or (4) When there is a specific relationship that has traditionally been recognized as involving fiduciary duties as with a lawyer and a client or a stockbroker and a customer."

(11) Meaning of fiduciary relationship disclose that such relationship exist when one person place trust or confidence to another in a particular matter. In the instant case after doing

away the duty of examination of the answer script, the examiner has returned the answer script to the APPSC. It is also not the case of the APPSC that the name of such examiner is mentioned somewhere in the answer script exposing to the applicant nor the applicant has sought for information to disclose the name of the examiner. In such a situation it is not understood as to how fiduciary relationship between the APPSC and the examiner would be violated in the event of allowing the applicant to peruse the answer script. It is also not the case of the APPSC that the examiner who inspected the answer script is still in the list of examiners i.e. regular of the subject in question for the APPSC.

- (12) There might be some fiduciary relationships between the examiner and the APPSC but in the absence of the necessary terms of engagement of the examiner and no materials to that effect having been placed before the Court by APPSC it is difficult to hold the existence of such a relationship. Even if there exists such a relationship, allowing to peruse the answer script to the applicant would not violate any such relationship justifying refusal of the prayer of the applicant under Section 8 (I) (e) of the Act.
- (13) The applicant appeared in an examination conducted by the APPSC being an applicant for appointment in a public post. The examination conducted by the APPSC for the said post has got involvement of public element. The applicant upon perusal of the evaluated answer script may find sufficient reason to raise further objection contending that the selection for the public post was not made in a proper and fair manner. That apart, it might also provided scope to rectify himself by knowing his deficiencies, if any. The information sought to be received by the applicant, in such a situation, is not personal information but the element of public interest is deeply rooted in it.
- (14) The regulations of the APPSC no doubt allow such right of perusal of answer script by an examinee but the regulation also does not provide that such prayer, if made, is required to be refused on any count. The rights of the applicant to receive the information and the circumstances under which such information is to be supplied has been provided in the RTI Act and the said right is not permitted to be denied or violated taking resort to non- inclusion of such right in the regulations of the APPSC. Suffice it to say the APPSC is guided by its regulation framed for the purpose of conducting selection of candidates, whereas the RTI Act provides a definite and specific right to the applicant.
- (15) The decision in Maharashtra's case (supra) relied on by the APPSC was rendered before enactment of RTI Act, when there was no such statutory recognition of right to information by a citizen. After coming into force of the Act, in the event a citizen can satisfy the requirement of the Act, the information sought for should be supplied to him. In this connection I am also fortified with a decision of Division Bench of this court rendered in

- (16) In view of what has been discussed and observed above, the petitioner/APPSC has failed to make out a case justifying interference with the impugned decision rendered by the Arunachal Pradesh Information Commission, in exercise of extraordinary jurisdiction of this Court under Article 226 of the Constitution of India.
- (17) In the result, the writ petition stands dismissed being devoid of merit. No costs.

In exercise of the powers conferred by clause (e) of sub-section (2) of section 27 of the Right to Information Act, 2005 (Act No. 22 of 2005), the Governor of Arunachal Pradesh hereby makes the following rules, namely:-

1. Short title and commencement:-

- (1) These rules may be called the Arunachal Pradesh Information Commission (Appeal Procedure) Rules, 2005.
- (2) They shall come into force from the date of their publication in the official Gazette.

2. Definitions:-

In these rules, unless the context otherwise requires:-

- (a) "Act" means the Right to Information Act, 2005.
- (b) "Section" means section of the Act.
- (c) "Commission" means the Arunachal Pradesh Information Commission;
- (d) Words and expression used herein and not defined but defined in the Act, shall have the meanings respectively assigned to them in the Act.

3. Contents of appeal:-

An appeal to the Commission shall contain the following information namely:-

- (i) name and address of the appellant;
- (ii) name and address of the Public Information Officer;
- (iii) particulars of the order against which the appeal is made including number, date and the State Public Information Officer who passed the order.
- (iv) brief facts leading to the appeal,
- (v) prayer or relief sought,
- (vi) grounds for the prayer or relief,
- (vii) provisions of the Act or the rules;
- (viii) verification by the appellant; and
- (ix) any other information which the Commission may deem necessary for deciding the appeal.

4. Documents to accompany appeal:-

Every appeal made to the Commission shall be accompanied by the following documents, namely:-

- (i) Attested true copy of the order against which the appeal is being preferred.
- (ii) Copies of documents relied upon by the appellant and referred to in the appeal; and
- (iii) An index of the documents referred to in the appeal.

1. Procedure in deciding appeal:-

In deciding the appeal the Commission shall,

- (i) hear oral or written evidence on oath or on affidavit from concerned or interested person;
- (ii) peruse or inspect documents, public records or copies thereof,
- (iii) inquire through authorized officer details or facts,
- (iv) hear State Public Information Officer, Assistant State Public Information Officer or such Senior Officer who decide the first appeal, as the case may be;
- (v) hear third party : and
- (vi) receive evidence on affidavits from State Public Information Officer, Assistant State Public Information Officer, such Senior Officer who decided the first appeal or third party.

2. Service of notice by Commission:-

Notice to be issued by the Commission may be served in any of the following modes, namely:-

- (i) Service by the party itself;
- (ii) by hand delivery (dasti) through Process Server;
- (iii) by registered post with acknowledgement due; or
- (iv) through Head of Office or Department.

3. Singing of Order:-

Order of the Commission pronounced in open proceeding shall be in writing and authenticated by the Registrar or any other officer authorized by the Commission for the purpose.

**4. CO Circle/BDO/CDPO office** : - Circle Officer/BDO/CDPO shall function as APIO in addition to his/her normal work.

In case of any transfer and posting or leave of the incumbent officer designated as Assistant Public Information Officer (APIO), the controlling authority concern of District/Division/Sub-Division/EAC (HQ) shall designate one of the officers to function as Assistant Public Information Officer till a regular officer is posted/join. The work of Assistant Public Information Officer shall not be allowed to stop due to transfer and posting or leave of the designated officer; the reliever of concerned APIO or the officer holding the charge temporarily shall automatically become APIO.

The undersigned is directed to refer Government notifications relating to appointment of PIO/APIO for various departments under the Government of Arunachal Pradesh and to say that some questions seeking clarification on the following points are constantly been pouring in this department for clarification.

The main problems/ confusions being received are:-

1. Some of the offices under the Government of Arunachal Pradesh are found be without PIO/APIO.
2. Whether appointment of APIO is compulsory in every department/offices?
3. There is frequent transfer of office already appointed as PIO/APIO.  
Whether every transfer should be followed by appointment of new PIO/APIO.

The matter has been examined in this department and it is now decided to clarify as under:-

- (a) This department has requested all the department/offices to nominate name and designation of their officers to be appointed as PIO. But some of the department/offices are found to be without PIO/APIO. The controlling officer of the offices which has not yet nominated or appointed PIO should automatically be treated as the PIO and his subordinate officer as the APIO under the provision of Section 5 of the Act.
- (b) The appointment of APIO is compulsory and necessity under the Act for convenience of the citizen in seeking information's from far of placed without going to the places where information's are available. According to sub-section (2) of the section 5 of the Act, the duties of APIO is to receive application requesting information/ appeal from the citizen and forward the same to concern PIO or senior officer specified under sub-section (1) of section 19 or the State Information Commission or the Central Information Commission as the case may be within five days. Forwarding of application may be done with information to concerned applicant invariably. Every APIO is to maintain a register as prescribed vide No.OM-106/2006 dated 7-11-2006.

(c) Frequent transfer and posting of officer from one place to another is within the administrative jurisdiction of the Government. Such transfer and posting of officers should not disturb the duties and responsibilities of the officer as PIO attached with post, the Relieving Officer should automatically accept the duties and responsibilities of PIO as he has replaced the Relieved Officer/PIO. So transfer of the concerned PIO/APIO should not require appointment of new PIO/APIO a fresh for that office. The responsibilities of PIO lie with the Relieving Officer. Hence, it is decided that no appointment of PIO/APIO shall be issued from the Nodal Department except proposal for appointment of new PIO.

(d) For the convenience of the citizens, the designated PIO or APIO should display distinctly in their office room as PIO or APIO as the case may be compulsorily.

It is requested to all the department/offices/PIOs/APIOs under the Government of Arunachal Pradesh to take note of the above clarification for compliance.


